The Context In the wake of the crisis faced by the teachers and students of the college due to the global pandemic caused by covid-19, Nalanda College adapted to face the challenge of crisis and provide better academic support. An online teaching and learning strategy framework was developed to provide an active and personalized mode of education for all the students to complete university curriculum for academic session. The various teaching and learning aids like e-content in form of e-books, digital library resources used to enhance learning skill. 4. The Practice To achieve such particular task there are different frameworks was developed, that is- a. Method of teaching: The various methods were adopted for teaching different theory-based courses as well as lab based courses by faculty members of the college. i. The Google Meet/Zoom application is used for utilization online mode of teaching. ii. WhatsApp groups were created when class PDF and doubt clearing session being send or organized. iii. PPT was prepared based on texts voice based lectures for critical explanations. b. Mode of evaluation: The time to time online examination conducted by department. c. Types of assignment: There are several methods used for it that is- i. An individual assignment sent in the group using WhatsApp. ii. An assignment questions in form of objectives and handwritten format. d. Outcome of teaching learning experience: During the Covid-19, the online teaching and learning experience enabled such as flexibility issues of time place for both teachers and students. Both teachers and students got the opportunity to explore new and innovative online resources. e. Evidence of success: The online learning encourages more productive use of time. It has greater access to experts and learners can access at their own pace and.
